CERTIFICATE OF COMPLETED NOTICE

To: The Public Service Commission, Frankfort, Kentucky

Pursuant to the Rules Governing Tariffs (effective August 4, 1984), I hereby certify that I am Robert C. Hazelrigg, Manager, External Affairs for Delta Natural Gas Company, Inc. ("Delta"), a utility furnishing natural gas service within the Commonwealth of Kentucky which, on the 23rd day of April, 2010, filed an application with the Kentucky Public Service Commission for the approval of an adjustment of the natural gas base rates, terms, and conditions of Delta, and that notice to the public of the filing of the application has been completed in substantial compliance with Section 8 of said Regulation, and 807 KAR 5:001, Section 10 (3) and (4), as follows:

That more than twenty (20) customers will be affected by said change by way of an increase in their rates or charges, and that on the 12th day of April, 2010, there was delivered to the Kentucky Press Service, Inc., an agency that acts on behalf of newspapers of general circulation throughout the Commonwealth of Kentucky in which customers affected reside, for publication in such newspapers once a week for three consecutive weeks beginning on April 20, 2010, pursuant to 807 KAR 5:011, Section 8(2)(c) and 807 KAR 5:001, Section 10(4), a notice of the filing of Delta's Application in this case. Publication of this notice is now complete, although some minor deviations occurred for which Delta is petitioning the Commission for

deviation under 807 KAR 5:001, Section 14 and 807 KAR 5:011, Section 14. An affidavit from the Kentucky Press Service, Inc. confirming this publication and a copy of said notice are enclosed in the envelope marked Exhibit A. The Kentucky Press Service, Inc. has presented to Delta proof of this publication of notice in the form of "tear sheets," which Delta will maintain in its files.

On the 17th day of April, 2010, notice was exhibited for public inspection at the main office and place of business of Delta, and the same will be kept open to public inspection at said office and place of business in conformity with the requirements of 807 KAR 5:011, Section 8.

I further certify that, beginning on April 23, 2010, Delta posted a copy of the proposed rates and tariffs on its website, and the same will remain on the website during the pendency of this proceeding.

The On-System Transportation Rate shall be the same as the Base Rate for Small Non-Residential, Large Non-Residential and Interruptible customers, as applicable, set forth above.

Delta Natural Gas Company, Inc. proposes a new Pipe Replacement Program tariff. Delta Natural Gas Company, Inc. also proposes a change to the Gas Cost Recovery tariff that provides recovery of Uncollectible Gas Costs through the GCR mechanism. Copies of the proposals may be obtained by contacting Emily P. Bennett, Delta Natural Gas Company, Inc., at 3617 Lexington Road, Winchester, Kentucky 40391, 859-744-6171, Ext. 116.

The foregoing rates reflect an annual proposed increase in revenues of approximately 11.54% to Delta Natural Gas Company, Inc. The estimated amount of annual increase per customer class is as follows: Residential GS: \$ 3,539,053, 15.8%; Small Non-Residential GS: \$ 593,368, 9.2%; Large Non-Residential GS: \$ 668,718, 7.3%; Interruptible: \$ 0, 0%; On-System Transportation: \$ 261,259, 6.3%; Off-System Transportation: \$ 253,030,7.4%.

The average monthly bill for each customer class to which the proposed rates will apply will increase approximately as follows:

Residential	\$	9.62	or	15.9%
Small Non-Residential	\$	11.95	or	9.2%
Large Non-Residential	\$	64.24	or	7.3%
Interruptible	\$	0.00	or	0.0%
On-System Transportation	\$	90.62	or	6.3%

The rates contained in this notice are the rates proposed by Delta Natural Gas Company, Inc.; however, the Public Service Commission may order rates to be charged that differ from the proposed rates contained in this notice.


Notice is further given that any corporation, association, body politic or person with a substantial interest in the matter may by written request, within thirty (30) days after publication of the notice of the proposed rate changes, request to intervene. The motion shall be submitted to the Public Service Commission, 211 Sower Boulevard, P. O. Box 615, Frankfort, Kentucky 40601, and shall set forth the grounds for the request, including the status and interest of the party. Intervention may be granted beyond the thirty (30) day period for good cause shown. Any person who has been granted intervention may obtain copies of the application and any other filings made by the utility by contacting Emily P. Bennett, Delta Natural Gas Company, Inc., 3617 Lexington Road, Winchester, Kentucky 40391, 859-744-6171, Ext. 116.

PETITION FOR APPROVAL TO DEVIATE FROM RULE

Delta Natural Gas Company, Inc. ("Delta") petitions the Kentucky Public Service Commission to grant Delta approval, pursuant to 807 KAR 5:011, Section 14, to deviate from the notice requirements of 807 KAR 5:011, Section 8(2) in the above-captioned proceeding because Delta has substantially complied with the Commission's notice regulations. In support of this petition, Delta states as follows:

- 1. On April 23, 2010, Delta filed an application with the Commission requesting approval of an adjustment of its existing rates. On April 12, 2010, Delta delivered to the Kentucky Press Service, Inc. a notice of the filing of its application for publication in twenty-six newspapers in Delta's service areas, once a week for three consecutive weeks, with the first publication to be made prior to the filing of Delta's application, as required by 807 KAR 5:011, Section 8(2)(c). See Certificate of Completed Notice.
- 2. Certain of the newspapers that were to publish notice of the filing of Delta's application omitted to publish the notice for the three consecutive weeks Delta instructed. As a result, the notice was not published for three consecutive calendar weeks in two of the twenty-six newspapers. This error did not affect Delta's compliance with the requirement that the first publication be made prior to the filing of Delta's application.¹

- 3. The two newspapers that did not publish notice of the filing of Delta's application once a week for three consecutive calendar weeks are the *Menifee County News* and the *Bath County News-Outlook*. The *Menifee County News* published the notice as scheduled on April 22, 2010, but failed to publish the notice in the next two calendar weeks as instructed. Notice was published, however, on May 13, 2010 and May 20, 2010. The *Bath County News-Outlook* published the notice as scheduled on April 21, 2010 and April 28, 2010, but failed to publish the notice in the following calendar week as instructed. Notice was published, however, on May 12, 2010. *See* Notarized Proof of Publication.
- 4. Due to the failure of the *Menifee County News* and *Bath County News-Outlook* to publish the notice for three consecutive weeks as instructed, Delta will not object on the basis of timeliness to a motion to intervene submitted by a customer in Delta's service areas in Menifee County and Bath County.
- 5. In addition to causing notice of the filing of its application in this case to be published in newspapers of general circulation in its service areas, Delta has posted the notice for public inspection at its office and place of business, as well as on its website. *See* Certificate of Completed Notice.
- 6. Delta has not received any complaint concerning the manner in which notice of the filing of its application was published.
- 7. The purpose of the Commission's regulation is to ensure that the public has sufficient notice of Delta's application and a meaningful opportunity to participate, individually or through representative agencies, in this proceeding. Despite the minor deviations noted above, notice was published in each county three times, and that notice was further supplemented by posting at Delta's offices and on its website. Delta's substantial compliance with the

Commission's regulation has met the purpose of the notice requirement. As stated by the

Kentucky Supreme Court

Substantial compliance in regard to publication requirements has been authorized. The purpose of the statute is to allow the public an ample opportunity to become sufficiently informed on the

public question involved.²

8. The Commission has authority to permit Delta to deviate from the publication

requirements pursuant to 807 KAR 5:011, Section 14.

9. Because Delta is in substantial compliance with the publication requirements of

807 KAR 5:011, Section 8(2)(c), good cause exists for the Commission to permit Delta to

deviate from the requirement of the regulation and to accept the publication of notice of Delta's

application as sufficient.

WHEREFORE, Delta Natural Gas Company, Inc. respectfully requests that the

Commission grant it approval pursuant to 807 KAR 5:011, Section 14 to deviate from the notice

requirements of 807 KAR 5:011, Section 8(2) and to accept the publication of notice of its

application as sufficient.
