# PETITION OF DELTA NATURAL GAS COMPANY, INC. FOR CONFIDENTIAL PROTECTION AND MOTION TO TO SUBSTITUTE DOCUMENT IN PUBLIC RECORD

Delta Natural Gas Company, Inc. ("Delta") respectfully petitions the Kentucky Public Service Commission ("Commission") pursuant to 807 KAR 5:001, Section 7 and KRS 61.878(1)(a) for confidential protection of its response to Item 94 of the Attorney General's Initial Request for Information dated May 24, 2010, herein "AG's First Request"). Further, since Delta inadvertently filed the confidential information contained in its Response to Item 94 in the public record of the Commission, Delta moves the Commission to substitute a redacted version of the response, which is attached hereto, for the unredacted version of the response that is currently in the public record.

In Item 94 of the AG's First Request, he sought a list by customer and amount and by year any uncollectible accounts which have been written off and which exceeded \$1,000. Delta supplied a response to the request which included the names of the customers. Those names are information of a personal nature where the public disclosure thereof could constitute a clearly unwarranted invasion of personal privacy. As such they are exempted from disclosure under the

Kentucky Open Records Act, KRS 61.878(1)(a). They should, therefore, be accorded confidential protection pursuant to 807 KAR 5:001, Section 7(2)(a)(1).

Since Delta has inadvertently filed an unredacted version of its response to Item 94 in the public record, Delta moves the Commission to substitute the attached redacted version of the response for the unredacted version in the public record. Ten (10) copies of the redacted version are attached hereto and one (1) copy of the unredacted version, with the confidential information highlighted, is attached hereto under seal, all pursuant to 807 KAR 5:001, Section 7(2)(a)(2).

WHEREFORE, Delta prays that the Commission grant confidential protection to its response to Item 94 of the AG's First Request as set forth above and substitute the redacted version of the response for the unredacted version in the public record.
