DATA REQUEST OF COMMISSION STAFF
TO BULLITT COUNTY SANITATION DISTRICT

Bullitt County Sanitation District ("BCSD"), pursuant to 807 KAR 5:001, is to file with the Commission the original and three copies of the following information, with a copy to all parties of record. The information requested herein is due on or before May 14, 2010. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.


Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

BCSD shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which BCSD fails or refuses to furnish all or part of the requested information, BCSD shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

All tax identification numbers, along with social security numbers, dates of birth, and e-mail addresses of individuals should be redacted from material to be filed herein. Otherwise, careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. After the proposed transfer is completed, are the customers of Pioneer Village to be charged the same rates as are in effect for BCSD customers? If not, provide the rates to be charged and explain the difference. Attach a copy of BCSD's rate schedule.
