QUESTION NO. 1

Responding Witness: Mark A. Martin

1. Do Atmos' transportation only customers receive one monthly invoice from Atmos that covers both transportation charges and commodity charges; or, alternatively, do such customers receive two monthly invoices: (a) one from Atmos for transportation charges; and, (b) a separate bill for the commodity charges from the third party supplier from whom the customer purchases its gas supply?

**RESPONSE:** All Atmos transportation customers receive two monthly invoices – one from Atmos for the transportation charge and one from the third party supplier for the commodity charge.

2. Does Atmos provide any billing services for its affiliate Atmos Energy Marketing (AEM)?

RESPONSE: No. AEM is treated exactly like all other third party suppliers. AEM bills its customers directly for the commodity charges.
