#### ORDER

On April 12, 2010, West Daviess County Water District ("West Daviess") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- West Daviess purchases water from Owensboro Municipal Utilities ("Owensboro").
- 2. Owensboro notified West Daviess that, effective with its June 1, 2010 billing, Owensboro's wholesale rate to West Daviess would increase from \$1.602 per 1,000 gallons to \$1.65 per 1,000 gallons.
- 3. West Daviess proposed a purchased water adjustment factor of \$0.06 per 1,000 gallons.
- 4. During the 12 months ending March 31, 2010, West Daviess purchased 391,430,500 gallons from Owensboro, and sold 333,987,140 gallons. The increase in the cost of purchased water is \$18,788.66, resulting in a purchased water adjustment of \$0.06 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.06 per 1,000 gallons is fair, just, and reasonable and should be approved.

### IT IS THEREFORE ORDERED that:

- 1. The proposed rates by West Daviess are approved.
- 2. The purchased water adjustment factor of \$0.06 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after June 1, 2010.
  - 4. The tariff sheets filed by West Daviess are approved as filed.
