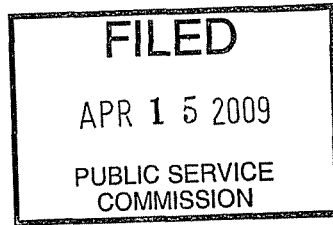

Enclosed please find the original and ten (10) copies of the Application of the North Mercer Water District for an Order authorizing the District to issue securities pursuant to KRS 278.300.


