ORDER

On April, 14 2010, Corinth Water District ("Corinth") applied to the Commission for an increase in its water rates. The proposed rates would increase revenue by \$158,668 or 24.84 percent over normalized revenue of \$638,674.

Commission Staff performed a limited financial review of Corinth's operations, and, on July 12, 2010, issued a Staff Report containing its findings and recommendations concerning the proposed rates.

All parties were directed to file written comments upon Staff's findings and recommendations or to request a conference or hearing no later than July 26, 2010.

In a letter to the Commission dated July 14, 2010 and filed with the Commission on July 19, 2010, Corinth accepted the findings and recommendations contained in the Staff Report. The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

- 1. The recommendations and findings contained in the Staff Report are supported by the evidence of record and are reasonable.
 - 2. Corinth's proposed rates will produce annual revenue of \$797,333.

IT IS THEREFORE ORDERED that:

- 1. The findings and recommendations contained in the Staff Report are adopted and incorporated by reference into this Order as if fully set out herein.
- 2. Corinth's proposed water rates, which are set forth in the Appendix to this Order, are approved for service rendered by Corinth on and after the date of this Order.
- 3. Within 30 days of the date of this Order, Corinth shall file with the Commission its revised tariff setting out the rates approved herein.
