

1. Gallatin is the largest end use customer located in the Owen Electric Cooperative ("Owen") service territory. Owen is in turn provided with generation and transmission service by East Kentucky Power Cooperative, Inc. ("EKPC").
2. The matters being decided by the Commission in this case may have a significant impact on the rates paid by Gallatin for electricity.
