Comes Woodland Acres Utilities Company, LLC ("Woodland Acres"), by counsel, and for its Notice of Filing, states as follows:

- 1. As indicated in the June 7, 2010, Intra-Agency Memorandum prepared by staff attorney J.R. Goff, an informal conference was held in the above-styled action on June 4, 2010. During this informal conference, Woodland Acres agreed to file a copy of any agreement it has with the Louisville Water Company. Accordingly, shortly after the June 4, 2010 informal conference, Woodland Acres requested the Louisville Water Company to provide such information.
- 2. Woodland Acres does not currently have a formal agreement with the Louisville Water Company with respect to the billing of the customers of the Woodland Acres Wastewater treatment plant. However, by letter dated June 29, 2010, the Louisville Water Company states that it currently pays Woodland Acres Sanitation the revenues it collects on a monthly basis and forwards these funds to Woodland Acres by the tenth day of the following month. The Louisville Water Company also provided an explanation of the billing charge incurred by Woodland Acres. The June 29, 2010 letter from the Louisville Water Company to Woodland

Acres Sanitation is attached hereto as Attachment A.

Dear Mr. Murphy:

Currently, Louisville Water Co. pays Woodland Acres Sanitation the revenues II collects on a monthly basis. Louisville Water Co. sends the funds to Woodland Acres Sanitation via EFT by the 10th day of the following month.

The Louisville Water Co. bills Woodland Acres Sanitalion's customers bi-monthly. Currently, Louisville Water Co. calculates a billing charge that is the sum of the proretion of \$3.24 per billing between the sewer utility and the water company in the same proportion that the sewer charge bears to the sum of the sewer charge and water charge on the joint bill. Over the past year, the per bill charge has ranged from \$1.30 per billing to \$1.46 per billing. The billing charges occur every other month.

According to the contract between the Louisville Water Co. and Woodland Acres Sanitation, the billing rate could change after a reasonable notice is given to Woodland Acres Sanitation.
