Filing Deficiencies

The Commission staff has reviewed your application in the above case. This filing is rejected for the reasons set forth below:

Filing deficiencies pursuant to 807 KAR 5:001:

(1) Section 10(3)(b) - The present and proposed rates for each customer class to which the proposed rates would apply.

A. The customer notice, Application, Exhibit E, shows nonrecurring charges as including "Special Meter Reading" with a proposed rate of \$30 whereas the proposed tariff, Exhibit B, PSC 38, Sheet No. 5, shows a proposed Special Charge for an automated meter reading of \$25.

B. The customer notice, Application, Exhibit E, shows nonrecurring charges as including "Temporary Service" with a proposed rate of \$40 whereas the proposed tariff, Exhibit B, PSC 38, Sheet No. 5, shows a proposed "Temporary Service" rate of \$70.

Filing deficiencies pursuant to 807 KAR 5:011:

(1) Section 6(2)(b) - In the case of a change in the text of any tariff sheet where the rate remains the same, the effective date shall remain the same as that on the amended sheet. The issued date of the change shall be the date the filing is made with the commission.

A. In Exhibit B, the proposed tariff has numerous sheets where text changes have been made but the Date of Issue has not been revised accordingly.

(2) Section 10(1)(b)(7) – The proposed tariff in a form which complies with 807 KAR 5:011 with an effective date not less than thirty (30) days from the date the application is filed.

A. In Exhibit B, PSC 38, Sheet No. 15, does not have an updated Date of Issue or an updated Date Effective.

The statutory time period in which the Commission must process this case will not commence until the above –mentioned information is filed with the Commission. If your filing contains a proposed effective date, the rejection of your filing for reasons of deficiencies voids the proposed effective date. When you file the required information to correct the deficiencies, you may re-file your proposed tariff with a new proposed effective date that is at least 30 days from the date you file the required information. You are requested to file 10 copies of this information within 15 days of date of this letter. If you need further assistance, please contact my staff at 502/564-3940.
