RE: Licking Valley Rural Electric Cooperative Corporation Show Cause

Pursuant to Licking Valley Rural Electric Cooperative Corporation's ("Licking Valley") request, an informal conference was held at the Commission's offices on August 24, 2010. A list of the attendees is attached hereto.

The purpose of the conference was to discuss the facts and circumstances surrounding Licking Valley's failure to report the December 2009 snow storm outages as required by 807 KAR 5:006, Section 26(1)(c). Prior to the informal conference, Licking Valley acknowledged its failure to comply with the regulation governing outage reporting and advised Commission Staff that it has revised its emergency restoration plan to specifically comply with 807 KAR 5:006, Section 26(1)(c). In response to Commission Staff's inquiries during the informal conference, Licking Valley described its emergency restoration procedures and the protocols implemented to ensure, when necessary, outage reporting compliance in the future.

There being no further discussion, the conference was adjourned.
