The purpose of the teleconference was for Commission Staff to ask a number of clarifying questions regarding Jackson Purchase's application in the above-styled case. Jackson Purchase has requested expedited treatment of its application to refinance certain loans with CoBank, ACB ("CoBank"). Commission Staff provided its questions to Jackson Purchase in advance of the teleconference in order to give its representatives time to prepare their responses.
