### ORDER

On June 15, 2010, Boone County Water District ("Boone County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Boone County purchases water from the Boone-Florence Water Commission ("Boone-Florence").
- 2. Boone-Florence notified Boone County that it would increase its wholesale water rates effective July 1, 2010. Boone-Florence's wholesale water rate to Boone County would increase from \$2.65 per 1,000 gallons to \$2.89 per 1,000 gallons. Boone County proposes to increase the water rates to its customers effective July 1, 2010.
- 3. During the 12 months ending April 30, 2010, Boone County purchased a total of 2,289,823,432 gallons of water from Boone-Florence and sold a total of 2,119,162,406 gallons of water. The increase in the cost of purchased water is \$549,557.62, resulting in a purchased water adjustment of \$0.26 per 1,000 gallons.

4. A purchased water adjustment of \$0.26 per 1,000 gallons is fair, just, and reasonable.

### IT IS HEREBY ORDERED that:

- 1. Boone County's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.26 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after July 1, 2010.
  - 3. The tariff sheets filed by Boone County in the application are approved.
