ORDER

Pursuant to 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED that:

- 1. - 3. All documents that Big Sandy filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9), during the period under review are incorporated by reference into the record of this proceeding.

4. Big Sandy shall publish the following notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Big Sandy shall file an Affidavit of Publication of Hearing Notice with the Commission no later than October 8, 2010.

A public hearing will be held on Tuesday, October 12, 2010, at 9:00 a.m., Eastern Daylight Time, at the offices of the Service Commission, 211 Sower Boulevard. Public Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Big Sandy Rural Electric Cooperative Corporation for the period November 1, 2009 through April 30, 2010. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than October 8, 2010. If no notices of intent to attend are received by that date, this hearing will be cancelled, and the matter shall be considered submitted for decision based on the evidence in the record.
