# ORDER

On December 29, 2009, in Case No. 2009-00202,<sup>1</sup> the Commission approved rates for Duke Energy Kentucky, Inc. ("Duke") and provided for their further adjustment in accordance with Duke's Gas Cost Adjustment ("GCA") clause.

On July 13, 2010, Duke filed its GCA to be effective August 2, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Duke's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Duke's Expected Gas Cost ("EGC") is \$6.447 per Mcf, which is a decrease of \$.266 per Mcf from its previous EGC of \$6.713 per Mcf.
- 3. Duke's notice sets out its total Refund Adjustment ("RA") of (\$.003) per Mcf, which represents no change from its previous total RA.
- 4. Duke's notice sets out its total Actual Adjustment ("AA") of \$.133 per Mcf, which represents no change from its previous total AA.

- 5. Duke's notice sets out its total Balancing Adjustment ("BA") of (\$.017) per Mcf, which represents no change from its previous total BA.
- 6. Duke's Gas Cost Recovery ("GCR") rate is \$6.560 per Mcf, which is a decrease of \$.266 per Mcf from its previous GCR of \$6.826 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after August 2, 2010.

## IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after August 2, 2010.
- 2. Within 20 days of the date of this Order, Duke shall file its revised tariffs with this Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
