Coolbrook C/N 2010-00314 2nd Data Request Responses

Question No. 1: Provide all logs, time sheets, journals, or any records that provide information about the dates and hours worked and duties performed for Coolbrook by Lawrence Smither and/or Martin Cogan.

Answer: We have not kept any records of time spent performing duties for Coolbrook because we weren't aware it was necessary. Mr. Smither routinely visits Coolbrook one day a week, but has not tracked his time while there. If the Commission indicates that it is cost beneficial for Mr. Smither and/or Mr. Cogan to track their time spent at the plant, doing administrative work, phone calls or any of the many items listed in the answer to question #3 of the first data request, on behalf of Coolbrook, we are willing to track time in the future.

Question No. 2: Does Coolbrook contract with Thacker Environmental to operate the sewer plant? (A) If yes, provide a copy of the contract. (B) Is there any shared management or ownership between Thacker Environmental, Coolbrook, Mr. Smither and/or Mr. Cogan?

Answer: Yes, Thacker Environmental is the operator of record for Coolbrook. Attached is the quote we received from Thacker Environmental on 12/18/08. We did not sign a formal contract with Thacker but gave them verbal approval to operate the plant as per the terms of the quote.

Jim and Kyle Thacker own Thacker Environmental and neither Mr. Smither nor Mr. Cogan have any financial interest in Thacker Environmental, so there is no shared management or ownership.

Question No. 3: Mr. Smither and Mr. Cogan are involved with four other sewer utilities. How do Fox Run Utilities, LLC, Brocklyn Utilities, LLC, and Lake Columbia Utilities, LLC, collect their fees and what has been their experience with collections.

Answer: The billing and collecting for Lake Columbia are done by the Louisville Water Company and we haven't had any collection issues there. The billing and collecting for Brocklyn and Fox Run are done by Integrity Bookkeeping. Brocklyn Utilities has significant collection issues such that we've hired a specialized collections company to attempt to address the situation, and we've used an attorney to assist us with some of the more difficult cases. Fox Run Utilities has few problems, but it only has less than 35 customers.

Coolbrook would also like to re-emphasize our nightmarish problems with billing and collecting at the Airview sewer system. Until a few years ago, Airview's billing and collecting was done by the Hardin County Water District, and there were very few collections problems. When Hardin County Water discontinued providing this service, we had to make other arrangements. Integrity Bookkeeping currently does Airview's billings, and residents of Airview that are either slow in paying or don't pay at all owe Airview Utilities a total of \$52,000. We have used the services of a collection agency and an attorney with very little success, and these services also cost money.

In summary, collection issues are rare for those sewer utilities that have had water utilities provide this service.

Question No. 4: Has Coolbrook considered advertising for competitive bids for the billing and collecting service? (A) If yes, provide a listing of the respondents, the amount of their bids, and the criteria under which the bids were sought. (B) Has Coolbrook considered doing its own billing

and collecting? If not, why not and what would be the cost of doing the billing and collecting inhouse?

Answer: No. As stated in prior responses, given our negative collections experience with Airview, Coolbrook has not advertised for bids and has not considered doing the billing and collecting in-house. Consequently, we don't know what the cost would be, although we do know that a competitive bidding exercise required by the PSC in a 2008 Farmdale Development sewer case did not yield attractive alternatives to Farmdale Water District providing this service. From our experience, collections go much better when the water utilities provide this service.

Question No. 5: What percentage of Coolbrook's bills have been considered uncollectible for each of the last five years and what was the amount of uncollectible for each of those years.

Answer: Coolbrook's present owners acquired the plant just over two years ago, and therefore cannot provide a 5-year history. However, within the two-year period of our ownership there haven't been any bills that were considered uncollectible, and we strongly believe this proves the benefits of the billing and collection arrangement (including the threat of disconnection) with Farmdale Water District, especially when compared to the significant uncollectibles experienced by the Airview sewer system.
