Kentucky Power Company – Alleged Failure to Comply with

Pursuant to the Commission's September 24, 2010 notice in the above-styled case, an informal conference ("IC") was held in this matter on October 5, 2010. A copy of the conference attendance list is attached. In addition to Commission Staff, representatives and counsel for Kentucky Power Company ("Kentucky Power") were in attendance.

The purpose of the IC was to discuss issues related to the Show Cause Order issued by the Commission on August 20, 2010. In its August 20, 2010 Order, the Commission alleged a violation of the National Electrical Safety Code ("NESC") stemming from an incident on June 15, 2009 in which a member of the public, William Wolf, came into contact with a service line which was below the height required by the NESC.

As a result of the discussions between Commission Staff and Kentucky Power, a proposed settlement was verbally agreed to and will be memorialized in a stipulation of facts and settlement agreement.

Commission Staff will draft the proposed settlement agreement and will send it to Kentucky Power's counsel for review. Once the settlement agreement is completed and signed, it will be sent to the Commission for review. If approved by the Commission, a final order will be issued stating that the Commission adopts the settlement agreement.
