And Responses To Data Requests


Kentucky Power Company moves the Commission for an extension through and including October 7, 2010 to file its direct testimony in this proceeding. Kentucky Power Company further requests that the period for filing its responses to the Commission Staff's data requests be extended through and including September 30, 2010.

The persons who formerly prepared the environmental surcharge filings under review, Errol K. Wagner and Bob Russell, retired from Kentucky Power on August 31, 2010. The additional time to prepare testimony is required to permit their replacements to become familiar with the surcharge filings prepared by Messrs. Wagner and Russell and to review the previously filed testimony sponsored by Mr. Wagner.

Kentucky Power Company requires additional time to file its response to the data requests to permit it to complete the gathering the necessary information and to provide the new personnel completing the responses sufficient time to investigate and verify the answers fully.

This motion is not made for purposes of delay and it is Kentucky Power's understanding that the requested extension will not prejudice staff's review of the testimony in its preparation for the October 14, 2010 informal conference.
