MOTION TO DEVIATE FROM RULE GOVERNING THE FILING OF COPIES

Comes Hillridge Facilities, Inc. ("Hillridge"), by counsel, and pursuant to 807 KAR 5:001, Section 14, hereby moves the Public Service Commission ("Commission") to authorize it to file the Original and two (2) complete copies of its Responses to Commission Staff's First Information Requests instead of the Original and ten (10) complete copies for the following reasons:

- On January 11, 2011, Commission Staff served its First Information Requests upon Hillridge. These First Information Requests directed Hillridge to provide copies of all invoices for the following expenses incurred by Hillridge in 2010 chemical expenses, routine maintenance expenses, outside services expenses, insurance expenses and maintenance of general plant expenses.
- Due to the number of records that Hillridge is required to produce in response to these First Information Requests and the fact that it is currently working to provide records to its accountant so that it will be able to timely file with the Commission its Annual Report, Hillridge requested an extension of time of twenty-one (21) days within which to respond to these First Information Requests. By Order entered on January 25, 2011, the Commission granted Hillridge an additional seven (7) days to file its response to the First Information

Requests.

- 3) Because of the large number of invoices that will be produced with its answers to the First Information Requests, Hillridge hereby requests that the Commission authorize it to file the Original of its Response and two (2) copies of the Response, all with a full set of the invoices attached. The additional eight (8) copies of the Responses filed with the Commission would not have copies of the invoices attached.
- The granting of Hillridge's motion would ensure that the Commission is provided with sufficient copies of the invoices needed to make its decision in the above-styled action, but enable Hillridge to file same in a timely manner without having to file at substantial additional cost, unnecessary voluminous duplicate copies. Service of documents upon parties granted full intervention status will be made as provided by the applicable rules.
