Dear Mr. Derouen:

Please accept this correspondence in response to the Commission Staff's request for clarification regarding Duke Energy Kentucky's Demand Side Management Application and more specifically membership in its Demand Side Management Collaborative. The inquiry came via telephone conversation in the presence of the Attorney General on May 23, 2011. The items for clarification posed to Duke Energy Kentucky are listed below and are accompanied by supplemental information.

## 1) Please identify the current Boone County Fiscal Court representative and specify whether the person identified in the application (Laura Pleiman) is the current representative.

Laura Pleiman was previously the representative for the Boone County Fiscal Court. When Duke Energy Kentucky emailed the invitation for the Collaborative meeting to review and approve the application in this case, the Company learned she was no longer in that position. Duke Energy Kentucky is uncertain if the Court has replaced her or appointed a new representative. The Boone County Fiscal Court did not send a representative to the Collaborative meeting nor has it

alerted anyone within Duke Energy Kentucky that there would be a replacement for Ms. Pleiman on the Collaborative.
