I am writing you regard to "Water Service Corp., Case No. 201000476"

On November 9, 2009 the PSC granted the WSKC (Water Service Corporation of Kentucky) a 29.5 percent rate increase. They had originally asked for a 50.80 percent raise. WSKC then immediately closed our local office putting several people out of work.

On December 3, 2010 (approximately 13 months after their 29.5 percent increase) WSKC notified the PSC that they intend to ask for an additional 21.90 percent raise in rates. IF this is allowed WSKC will be getting a total 51.40 percent raise in a little over a year.

I am on disability. There's a lot of folks on a fixed income in this town. We haven't received a raise in our checks for two years now. I vehemently oppose any more raise for the WSKC. Your help on this matter will be greatly appreciated.
