Informal Conference of May 19, 2011

Pursuant to the Commission Staff's ("Staff") notice issued on May 17, 2011, an informal conference was held at the Commission's offices on May 19, 2011. In attendance were representatives of Duke Energy Corporation, Cinergy Corp., Duke Energy Ohio, Inc., Duke Energy Kentucky, Inc., Diamond Acquisition Corporation, and Progress Energy, Inc. (collectively "Joint Applicants"), and the Attorney General's Office and Staff. A list of attendees is attached to this memorandum.

The Joint Applicants presented some background information on the operations and structure of Progress Energy, Inc. ("Progress"). They then discussed conflicts that some of their witnesses have with the scheduled hearing date of July 6, 2011 and suggested alternative dates for the hearing. The Joint Applicants agreed to file a motion requesting the Commission to revise the hearing date and include the alternative dates in that motion.

Next, the Joint Applicants addressed the Commission's May 9, 2011 Order rejecting for filing the errata to the original testimony of Mr. William D. Wathen. They stated that filing the errata was not meant to make a substantive change to Mr. Wathen's testimony and that they did not intend to file an amendment to revise their application or Mr. Wathen's testimony. They also wanted to clarify that the revised Money Pool Agreement that was also filed with the errata was not in question and was acceptable for filing since it was not addressed in the Commission's May 9, 2011 Order. Staff confirmed that the revised Money Pool Agreement was not in question.

Finally, the Joint Applicants stated that they had just filed a supplemental response, under confidential seal, to Item 32 of Staff's Initial Information Request. This supplemental response consisted of a document that was filed the day before as part of their North Carolina merger proceeding and they believed it warranted filing in this proceeding as well.

There being no further discussions, the informal conference was adjourned.
