On June 8, and June 17, 2011, Informal Conferences "(IC") were convened in this case at the Commission's Frankfort offices and were attended by representatives of Duke Energy Corporation ("Duke Energy"), Progress Energy, Inc. ("Progress"), the Attorney General of the Commonwealth of Kentucky and Commission Staff. The attendance lists for the two meetings are attached to this memorandum.

The purpose of the June 8<sup>th</sup> IC was to discuss possible settlement of the issues in this case regarding the acquisition of Progress by Duke Energy. After some discussion of settlement terms on June 8, the parties adjourned the meeting with the expectation that an additional IC would be held the following week to continue the discussion. The parties reconvened at the Commission's offices on June 17 and informed staff that they had met earlier in the week and reached an agreement in principle to the terms of a settlement. The terms of the settlement were discussed and, once reduced to writing and filed, the settlement is intended to be a complete resolution of all issues in the case. The parties indicated their intent to file the settlement agreement with the Commission prior to the hearing on July 8. Procedural items related to the hearing were also discussed.

There being no other matters to discuss, the IC was adjourned.
