ORDER

On August 9, 2011, Forest Creek, LLC filed a formal complaint against Jessamine-South Elkhorn Water District ("JSEWD") regarding a request for a water line extension. On September 19, 2011, JSEWD filed a response to the complaint.¹ On April 25, 2012, JSEWD filed a motion to dismiss complaint and alternatively, motion to suspend proceedings and supplement the record. Forest Creek, LLC filed a memorandum on May 17, 2012, opposing JSEWD's motions.

Prior to the Commission's issuing a decision on JSEWD's April 25, 2012 motion, the parties filed a joint motion on August 24, 2012, to hold the proceeding in abeyance for 30 days. The Commission granted that motion, as well as subsequent motions, holding the proceeding in abeyance through January 8, 2013.

¹ The parties also have a circuit court action regarding the same subject matter. *Jessamine-South Elkhorn Water Dist. v. Forest Creek, LLC,* Civil Action No. 2010-CI-001394 (Jessamine Cir. Ct. Ky filed Dec. 17, 2010). After the Commission intervened in that action, the trial court dismissed the action for lack of subject matter jurisdiction. JSEWD appealed the decision. In an unpublished decision, the Court of Appeals reversed the trial court and found that the subject matter was a contractual issue that does not invoke the Commission's exclusive jurisdiction over rates and services. 2013 WL 3480344 (Ky. App.).

Since holding the proceeding in abeyance, the parties have been attempting to resolve the issues and Commission Staff has held approximately ten informal conferences with the parties to discuss the status of their negotiations. The most recent informal conference occurred on May 22, 2014. The parties indicated that if they are unable to resolve all issues by June 2, 2014, they want to file supplemental briefs on JSEWD's April 25, 2012 motion to dismiss. As of the date of this Order, the parties have not advised the Commission regarding resolution of any issues.

Having carefully reviewed the status of this proceeding, we find that a procedural schedule should be established to allow the parties an opportunity to file supplemental briefs on JSEWD's April 25, 2012 motion to dismiss.

IT IS THEREFORE ORDERED that the procedural schedule set forth in the Appendix attached hereto and incorporated herein shall be followed in this case.
