### ORDER

On February 4, 2011, North Hopkins Water District ("North Hopkins") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. North Hopkins purchases water from the city of Madisonville ("Madisonville").
- 2. Madisonville notified North Höpkins that, effective March 1, 2011, Madisonville's wholesale water rate to North Hopkins would increase from \$3.79 per 1,000 gallons to \$3.95 per 1,000 gallons. North Hopkins proposes to increase the water rates to its customers effective March 1, 2011.
- 3. North Hopkins proposed a purchased water adjustment factor of \$0.20 per 1,000 gallons.
- 4. During the 12 months ending December 31, 2010, North Hopkins purchased 87,261,000 gallons of water and sold 68,899,600 gallons. The increase in


the cost of purchased water is \$13,961.76, resulting in a purchased water adjustment of \$0.20 per 1,000 gallons.

5. The purchased water adjustment of \$0.20 per 1,000 gallons is fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by North Hopkins are accepted.
- 2. The purchased water adjustment of \$0.20 per 1,000 gallons and the rates shown in Appendix A, attached hereto and incorporated herein, are approved for service that North Hopkins renders on and after March 1, 2011.
- 3. Within 20 days of the date of this Order, North Hopkins shall file a revised tariff sheet with the Commission reflecting the rates approved herein and signed by an officer of North Hopkins authorized to issue tariffs.
