NOTICE OF INTENT TO IMPLEMENT RATE INCREASE

Comes Jackson Purchase Energy Corporation ("JPEC"), by and through counsel and states as follows:

Whereas, on June 8, 2011, JPEC filed an Application, pursuant to KRS 278.455(2), with this Commission for approval of rates to flow-through an increase requested by its wholesale supplier, Big Rivers Electric Corporation, in Case Number 2011-00036. This Commission, by Order dated March 17, 2011, suspended Big Rivers' proposed rates from taking effect until September 1, 2011.

KRS 278.455(2) provides that the rates of a distribution cooperative shall become effective on the same date as those of its wholesale supplier. By Order dated June 13, 2011, the Commission stated, "Jackson Purchase's proposed rates will be effective the same date as Big Rivers' rates in Case No. 2011-00036 in order that the timing of any change in Jackson Purchase's retail rates will be synchronized with the timing of any change in Big Rivers' wholesale rates."

Big Rivers provided the Commission with notice, pursuant to KRS 278.190, that it intends to implement its requested rates, subject to refund, effective September 1, 2011. As such, JPEC hereby notifies the Commission that it elects to place those rates into effect on September

1, 2011, subject to refund, pending the issuance of a final order by the Commission in Case Number 2011-00036.
