## COMMISSION STAFF'S FIRST DATA REQUEST TO ATMOS ENERGY CORPORATION

Atmos Energy Corporation ("Atmos"), pursuant to 807 KAR 5:001, is to file with the Commission the original and ten copies of the following information, with a copy to all parties of record. The information requested herein is due no later than May 9, 2011. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Atmos shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Atmos fails or refuses to furnish all or part of the requested information, Atmos shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Provide the name of each Atmos affiliate and explain the type of service each affiliate provides.

2. For each affiliate identified in Item 1 whose name includes the word Atmos, please state whether that affiliate uses the name Atmos in any written, audio or televised format and describe how it is used.

3. State whether any Atmos affiliate identified in Item 2 specifically identifies itself as an Atmos affiliate.

4. Explain whether any Atmos affiliate identified in Item 2 uses any type of letterhead, invoices, business cards, uniforms or vehicles using the name Atmos.
