



 - a. Explain whether it is Delta's position that Delta Resources is the only affiliate that is required to use the proposed disclaimer.
 - b. Explain whether Delgasco specifically states that it is an affiliate of Delta in any written, televised or audio format.
 - c. State the type of services Delgasco provides.
 - d. State whether Delgasco uses any type of letterhead, invoices, business cards, uniforms or vehicles using either the name Delgasco or Delta.
 - e. State whether Delgasco uses the name Delgasco or Delta in any audio or televised format.
 - f. State whether Enpro uses the Delta name in any written or audio format.

RESPONSE:

- a. It is Delta's position that Delta Resources is the only affiliate that is required to use the proposed disclaimer as prescribed by 807 KAR 5:080. Delta's name is not included in the names of the other affiliates.
- b. Delta discloses that Delgasco is a subsidiary in the company's required quarterly and annual SEC filings. Delgasco does not utilize other written, televised or audio format.
- c. Delgasco purchases natural gas and sells it to others not on Delta's system.
- d. Delgasco uses letterhead and invoices using Delgasco's name. Delta's name is not included on the letterhead or invoices.
- e. Delgasco does not utilize any audio or televised format.
- f. Enpro does not utilize any written or audio format.
