O R D E R

On April 29, 2004, in Case No. 2003-00411,<sup>1</sup> the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), and provided for their further adjustment on a quarterly basis in accordance with Equitable's Gas Cost Adjustment ("GCA") clause.

On June 22, 2011, Equitable filed its proposed GCA to be effective August 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Equitable's Expected Gas Cost ("EGC") is \$8.0704 per Mcf, which is an increase of \$1.2978 per Mcf from its previous EGC of \$6.7726 per Mcf.
3. Equitable's notice sets out a current quarter Actual Adjustment ("AA") of (\$.1428) per Mcf. Equitable's total AA is (\$.3950) per Mcf, which is an increase of \$1.9170 per Mcf from the previous total AA of (\$2.3120) per Mcf.

4. Equitable's notice sets out a current quarter Balancing Adjustment ("BA") of \$.0074 per Mcf. Equitable's total BA is (\$.0073) per Mcf, which is an increase of \$.0500 per Mcf from the previous total BA of (\$.0573) per Mcf.

5. Equitable's Gas Cost Recovery Rate is \$7.6681 per Mcf, which is an increase of \$3.2648 per Mcf from its previous rate of \$4.4033 per Mcf.

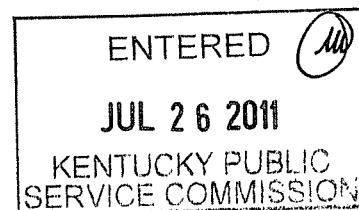
6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Equitable on and after August 1, 2011.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for final meter readings on and after August 1, 2011.
