The North Shelby Water Association is respectfully requesting that our tariff be amended to delete the page regarding the "Fire Protection Tariff", copy attached This charge was adopted in 2000 and its purpose was to apply a charge to a new Shelby County School Facility that had installed a fire protection facility. This is the only facility that has ever been charged a Fire Protection Rate. The rate is \$0075 per square foot of sprinklered space which amount to \$90 per month.

The purpose of removing this language is because it conflicts with our position of not providing guaranteed fire protection to any of our service area. We recognize that we have areas of our system that meet your minimum standards for fire protection but the exact location of that service changes with the demand and operation of our water system continuously. The majority of our system does not meet the minimum standards for fire protection and we are of the opinion that it is unfair to assess a charge to any customer or customers particularly where this service is not available on a consistent basis.
