ORDER

On July 19, 2011, Levee Road Water Association ("Levee Road") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Levee Road purchases water from the city of Mount Sterling, Kentucky ("Mount Sterling").
2. On May 1, 2011, Mount Sterling increased its volumetric wholesale rate to Levee Road from \$2.07 per 1,000 gallons to \$2.34 per 1,000 gallons.
3. On July 14, 2011, the members of Levee Road's Board of Directors voted to increase Levee Road's rates, effective August 1, 2011, commensurate with the increase in Mount Sterling's wholesale rate.
4. Levee Road proposes a purchased water adjustment factor of \$0.34 per 1,000 gallons.
5. During the 12 months ending May 31, 2011, Levee Road purchased 53,462,029 gallons of water from Mount Sterling and sold 43,020,856 gallons of water.

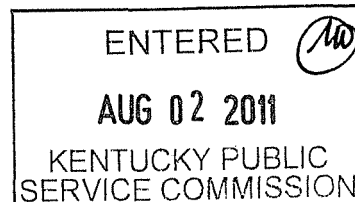
The increase in the cost of purchased water is \$14,434.74, resulting in a purchased water adjustment factor of \$0.34 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.34 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. Levee Road's proposed rates are approved.
2. The purchased water adjustment factor of \$0.34 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B are approved for services rendered on or after August 1, 2011.
4. Within 20 days of the date of this Order, Levee Road shall file with the Commission a revised tariff sheet showing the rates approved herein.
