**RE:** Telephonic Informal Conference of September 9, 2011

On September 9, 2011, a telephonic informal conference ("IC") was conducted to discuss issues pertaining to this case. Participants in the IC were representatives of Kenergy Corp. ("Kenergy") and Commission Staff ("Staff") (a list of the participants is attached to this memorandum).

Staff had initiated the IC to get clarification on information contained in Kenergy's application, including, but not limited to, Kenergy's request for expedited consideration of its application. Staff also asked a number of specific questions regarding Kenergy's request for a Certificate of Public Convenience and Necessity to construct a new microwave communication system.

Kenergy responded adequately to the questions raised by Staff. It also indicated that it would file the information requested by Staff regarding the construction timeline for the new microwave system and how it would account for the retirement of the existing microwave communication system. Kenergy stated it should be able to file the additional information early in the week of September 12, 2011.

With the discussion concluded to everyone's satisfaction, the IC was adjourned.
