O R D E R

On October 21, 2010, in Case No. 2010-00116,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On September 23, 2011, Delta filed its proposed GCA to be effective October 24, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$5.2090 per Mcf, which is a decrease of \$1.3082 per Mcf from the previous EGC of \$6.5172 per Mcf.
3. Delta's notice sets out a current quarter Refund Adjustment ("RA") of (\$.0152) per Mcf. Delta's total RA is (\$.0524) per Mcf, which is a decrease of \$.0080 per Mcf from the previous quarter total RA of (\$.0444) per Mcf.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0449) per Mcf. Delta's total AA is \$.8305 per Mcf, which is a decrease of \$.2301 per Mcf from the previous total AA of \$1.0606 per Mcf.

5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.0472) per Mcf, which represents an increase of \$.4209 per Mcf from the previous BA of (\$.4681) per Mcf.

6. Delta's GCA is \$5.9399 per Mcf, which is a decrease of \$1.1254 per Mcf from the previous GCA of \$7.0653 per Mcf.

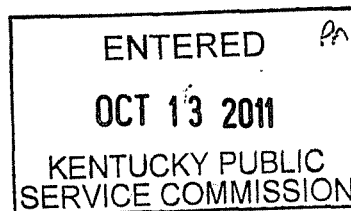
7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after October 24, 2011.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order are approved for final meter readings on and after October 24, 2011.
