## QUESTION:

In regards to the Energy Efficiency Education Programs for Schools Program, what is the cost of an Energy Efficiency Starter Kit?

## **RESPONSE:**

Free Energy Efficiency Starter kits are available to children families (both Duke customers and Non-Duke customers) participating in the School Program. The program cost of the energy efficiency starter kit is \$15.26 per Duke customer (just the kit contents). There is a smaller starter kit, (fewer measures) that is available upon completion of a survey to the Non-Duke customers with children participating in the Schools program. The Non-Duke customer starter kit costs \$7.10 per kit. Duke Energy does not claim savings for Non-Duke customers, but engages the Non-Duke families to make sure all students have a similar experience which improves school adoption of the program.
