O R D E R

This matter arises upon the motion of Kentucky Industrial Utility Customers, Inc. ("KIUC") filed June 27, 2012 for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that KIUC should be granted full rights of a party in this proceeding.


IT IS HEREBY ORDERED that:

1. The motion of KIUC to intervene is granted.
2. KIUC shall be entitled to the full rights of a party and shall be served with electronic notice of the issuance of all Commission Orders issued after the date of this Order and of all documents filed by any party to this proceeding.
3. KIUC shall comply with all provisions of the Commission's Order of June 22, 2012 related to the electronic filing of documents.
4. Within five days of entry of this Order, KIUC shall:

a. Notify the Commission and all other parties of record in writing of the electronic mail address to which all electronic notices and messages related to this proceeding should be served.

b. File a written statement as to whether it, or its agent, is capable of receiving electronic transmissions, and whether it waives its right to service of Commission Orders by United States mail in return for electronic notification of the issuance of such Orders.
