We Kentuckians have the right to be secure in our houses against unreasonable seizures and the stat collecting droids attached to the sides of our houses are seizing statistics about our personal lives. It is unreasonable to suggest that I have alternatives to this intrusion because we all know that these companies clearly operate as monopolies and do not allow us a free market choice.

Here are two simple solutions:
