Application of Big Rivers Electric Corporation for Approval of Its 2012 Environmental Compliance Plan, for Approval of Its Amended Environmental Cost Recovery Surcharge Tariff, for Certificates of Public Convenience and Necessity, and for Authority to Establish a Regulatory Account

At the request of Kentucky Industrial Utility Customers, Inc. ("KIUC"), a telephonic informal conference was conducted on July 12, 2012. A list of the attendees is attached hereto.

The purpose of the conference was to discuss KIUC's request for an extension of time to file intervenor testimony. KIUC's counsel provided a background explanation concerning the need to have additional time to resolve certain outstanding discovery issues, which in turn would impact the ability for KIUC to file its testimony in this matter addressing Big Rivers Electric Corporation's ("Big Rivers") proposal to approve its 2012 Environmental Compliance Plan. Big Rivers' counsel objected to KIUC's request for an extension, arguing that Big Rivers had fully complied with any and all discovery requests propounded by the parties in this matter to Big Rivers. After further discussions, the parties were able to arrive at a reasonable resolution of the issue. It was agreed that the deadline for the filing of intervenor testimony would be extended from the current due date of July 18, 2012 to July 23, 2012, and the deadline for data requests to intervenors would be extended from July 27, 2012 to July 30, 2012. The remaining dates on the current procedural schedule would remain unchanged.

There being no further discussions, the informal conference was adjourned.
