Dear Mr. Kamuf:

The Public Service Commission has received the Petition for Confidential Treatment filed on May 24, 2012 on behalf of Big Rivers Electric Corporation ("Big Rivers") to protect certain information filed with the Commission as confidential pursuant to Section 7 of 807 KAR 5:001 and KRS 61.878. The information sought to be treated as confidential is contained in Big Rivers' Response to KIUC's Letter dated May 11, 2012. The information is described as a CD containing a number of planning models performed by ACES Power Marketing which include detailed information regarding cost of producing power; projections relied upon relating to fuel prices, power market prices, and allowance prices and needs; and lists of scheduled outages. In addition to its Petition for Confidential Treatment, Big Rivers filed 2 Motions for Deviation on June 1, 2012 and July 6, 2012 which encompass multiple confidential filings. The Commission granted Big Rivers' Motions for Deviation from the filing requirements in 2 Orders dated August 3, 2012.


Big Rivers has requested the Commission treat this material as confidential because public disclosure of the information could result in an unfair commercial advantage to competitors.

Based on a review of the information and pursuant to KRS 61.878 and 807 KAR 5:001, Section 7, the Commission has determined that the information requested to be held confidential is of a proprietary nature, which if publicly disclosed would permit an unfair commercial advantage to Big Rivers' competitors. Therefore, the information requested

to be treated as confidential **meets the criteria for confidential protection** and will be maintained as a nonpublic part of the Commission's file in this case. The procedure for usage of confidential materials during formal proceedings may be found at Section 7(8) of 807 KAR 5:001.

If the information becomes publicly available or no longer warrants confidential treatment, Big Rivers Electric Corporation is required by Section 8(9)(a) of 807 KAR 5:001 to inform the Commission so that the information may be placed in the public record.
