Louisville Gas and Electric Company – Alleged Failure to Comply with

Administrative Regulations

On July 20, 2012, Commission Staff ("Staff") held an informal conference ("IC") with representatives of Louisville Gas and Electric Company ("LG&E"). The purpose of the IC was to discuss issues related to the case and possible settlement of all issues. LG&E requested the conference and notice of the IC was issued by the Commission on July 19, 2012. A sign-in sheet listing the attendees is attached to this memorandum.

The IC began with a general discussion of LG&E's presentation and handout from the IC held at the Commission's offices on June 12, 2012. Staff then reviewed its concerns regarding LG&E's six errors involving Clayton. Specifically discussed was the nature of the individual errors made with five of the six errors pertaining to Clayton's "split account." LG&E described the extensive training that is now given to employees on how to handle all aspects of split accounts. The sixth error involving Clayton's service being disconnected while her informal complaint was pending before the Commission has been addressed by a new procedure instituted by LG&E.

Finally, there was a discussion of a possible settlement of the case. An initial draft settlement agreement will be prepared by LG&E and tendered to Staff by July 27, 2012 for its review.

The IC was then adjourned.
