Nolin Rural Electric Cooperative Corporation, hereinafter called the "APPLICANT", respectfully advises the Commission that:

- 1. APPLICANT is engaged in the sale of electric power over its 2,991.48 miles of line at retail rates to its approximately 33,753 meters in Hardin, LaRue, Green, Taylor, Meade, Breckinridge, Grayson and Hart Counties, Kentucky. In the City of Vine Grove, the APPLICANT serves 1,104 meters.
- 2. The address of APPLICANT is 411 Ring Road, Elizabethtown, Kentucky 42701, and its Articles of Incorporation, as amended, are on file with the Commission in Case No. 93-324, styled "Application for Authorization to Obtain Five Year Line of Credit".

- 3. This Application is, in essence, to bid on a franchise pursuant to KRS 278.020(4).
- 4. The City of Vine Grove, Kentucky is the governmental agency offering the franchise.
- 5. The type of franchise being offered is an electric franchise.
- 6. In this instance, there is a definite need and demand for such services, since the services are already being provided to the particular municipality in question. The APPLICANT has served consumer/members in this area since 1939. The reason for the application herein is that the APPLICANT has been serving portions of the municipality in the past pursuant to a previous franchise granted to the APPLICANT, and that franchise has now expired after 20 years, and the municipality is preparing to accept bids for such a franchise. The Consent of the City of Vine Grove to the entry of an Order granting the issuance of such a certificate is attached as Applicant's Exhibit "A".

WHEREFORE, the APPLICANT now moves the Public Service Commission of the Commonwealth of Kentucky to grant the said certificate of convenience and necessity for an electric franchise in those areas of the City of Vine Grove, Kentucky, within the territory of the APPLICANT, which the APPLICANT has herein requested and which the Commission has discretion to do pursuant to KRS 278.020(4), upon determination that there is a need and demand for the service.
