RE: Telephonic Informal Conference of October 10, 2012

Pursuant to a Commission Staff's Notice of Telephonic Informal conference issued October 2, 2012, a telephonic informal conference was conducted at the Commission's offices in Frankfort, Kentucky on October 10, 2012. A list of attendees is attached.

Louisville Gas and Electric Company ("LG&E") indicated that it has established an agreement¹, available for customers who own various properties, whereby the owner/landlord of the property can leave utility service on in a particular rental unit after a tenant moves out. LG&E explained that property owners/landlords may want such an arrangement for various reasons, including being able to have utility service remain on when the unit is cleaned. LG&E explained that Mr. Nichols has had in place for the past several years such an agreement.

LG&E indicated a willingness to discuss the matter with Mr. Nichols and the parties agreed they will meet to discuss the issues. The parties will file a status report by November 1, 2012.

There being no additional matters to discuss, the conference was adjourned.
