ORDER

Pending before the Commission is a motion filed by Louisville Gas and Electric Company ("LG&E"), with the concurrence of the Attorney General's Office ("AG") and Kentucky Industrial Utility Customers, Inc. ("KIUC"), to modify the existing procedural schedule. The motion requests an extension of eight days for the filing of intervenor testimony, revised dates for discovery to intervenors and responses from intervenors, and no change in the due date for LG&E's rebuttal testimony. The motion states that the delay is needed because the use of electronic case procedures has created practical issues of first impression for the AG and KIUC in accessing the documents filed electronically.

Based on the motion and being otherwise sufficiently advised, the Commission finds good cause to revise the procedural schedule as requested.

IT IS THEREFORE ORDERED that:

1. LG&E's motion to revise the procedural schedule is granted.
2. The procedural schedule set forth in the Appendix, which is attached hereto and incorporated herein, shall be followed for the remainder of this case.


3. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
