



REQUEST

Please provide a description of how Kentucky Power Company intends to run the lines into Sand Gap Estates to serve the customers at issue (and any additional customers that might build in its service territory).

RESPONSE

Kentucky Power would need to construct approximately 3,722 ft of new #2Al single phase primary line to serve both customers in the Sand Gap Estates subdivision. The new line extension would follow the existing Sand Gap Road, in a southwesterly direction, from our existing pole 38830065D20035, which is located at the Sand Gap Church. The first customer, Porter at 414 Sand Gap Road, would be served at approximately 1,807 feet from the takeoff pole to Grayson RECC's pole #3019-28. Beyond GRECC pole #3019-28 we would install 2 spans of #2Al single phase primary to the corner of Lot 15 and to Lot 16 approximately 515 feet. From GRECC's pole #3019-28 we would span approximately 140 feet southeast to the corner of Lot 37. At this point we would construct 1,260 ft. of #2Al single phase line along Olivia Blvd. Southwest to GRECC's pole which serves Lot #28 at 397 Olivia Blvd.


REQUEST
