To Whom it May Concern:

The Nebo Water District has decided to start imposing deposit's to cover part of the lost revenue we occur. We feel that it is necessary to ask renters for more of a deposit than property owners, because they leave owing the water system the most. In 2011 we had 86 renters sign onto the system.

At the end of the year we had 69 customers that left the system owing money, a total of \$7,278.61, of which only one was a home owner. There were 68 renters leaving the system owing a total of \$7,169.65 last year with an average of \$105.44 each. We feel that a deposit of \$75.00 per renter is reasonable and would help offset the loss.

### Deposits

The Nebo Water District will require a deposit to secure payment of bills. Service will be refused for failure to pay the requested deposit. Interest, as prescribed by KRS.74050, will be added annually to the customer's deposit. Upon termination of service the deposit with any interest will be credited toward the customer's final bill, with any remainder refunded to the customer.

The deposit will be no more than 2/12 of the average annual residential customers bill. The deposit for any customer that does not own the property to which the service is requested will be 75.00. For those who own the property the deposit will be 25.00. A connection fee, that is non-refundable, of 25.00 will also be required for all customers.

In the event a customer leaves without notice in writing to the water department or water is terminated by the water department because of non-payment of services the customer's deposit will be used toward their final bill with the remainder being forfeited.

### Non-recurring Charges:

Deposits - Property Owner	\$25.00
Deposits - Renter	\$75.00

The rates contained in this notice are the rates proposed by Nebo Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed fees. Such action may result in rates for consumers other than the rates in this notice.

Any corporation, district, body politic, or person may request leave to intervene by motion within 30-days after notice of the proposed rate changes are given.
