Commission Staff began the conference by informing all parties that Owen's motion to withdraw Case No. 2012-00468 "The Application of Owen Electric Cooperative Corporation for Revisions to its Meter Reading Tariff to Accommodate Manual Meter Reading Charges in Instances where its Advanced Metering Infrastructure is Prohibited from being Utilized for its Intended Purpose" was granted without prejudice.
