Mr. Mattingly and Ms. Nicholas:

Another issue has arisen with Marion County Water District's application. When reviewing the application, I focused upon the filing requirements necessary for a certificate of public convenience and necessity. The application, however, also seeks authorization to enter a loan agreement with the Kentucky Infrastructure Authority to borrow \$548,180. It must meet the filing requirements set forth in 807 KAR 5:001, Section 11. (Amendments to 807 KAR 5:001 became effective on 1/4/2013. In the new version of the regulation, Section 11 is now Section 17.)

A list of the item necessary to meet these requirements is attached. The application meets many of these requirements. The items that are not presently in Marion County Water District's application are highlighted. Most of the requirements relate to a financial exhibit that covers a period ending not more than 90 days prior to the date of the application. Most water districts in lieu of filing a financial district make reference to their most recent annual report on file with the Commission. If that report does not cover a period within 90 days of the date of the application, the water district usually files a request to deviate from 807 KAR 5:001, Section 11 to permit the use of its most recent annual report. To support that request, it represents that the material condition of the water district has not change since the filing of the annual report.

To expedite matters, I recommend that the water district in a letter to the Commission supply the missing information to the extent possible, make reference in its submission to the water district's 2011 annual report, which is on file with the Commission, request that the 2011 annual report be incorporated by reference into the application and request a deviation from 807 KAR 5:001, Section 11, to permit the 2011 annual report to substitute as the required financial exhibit.

If you can transmit this information to me by e-mail, I will ensure that it is added to the case record.
