STAFF-DR-01-001 SUPPLEMENTAL

### **REQUEST:**

Refer to Duke Kentucky's response to Item 1 of the Commission's February 13, 2013 Request for Information. State whether the proposed per-unit fuel cost of \$.027466 is representative of current fuel costs.

#### RESPONSE:

The actual per-unit fuel costs for the period January 2012 through February 2013 are from a low of \$0.027466 per kilowatt-hour in June 2012 to a high of \$0.030639 per kilowatt-hour in March 2012. The 14 month average actual per-unit fuel cost for the period January 2012 through February 2013 is \$0.028835 per kilowatt-hour.

The proposed per-unit fuel cost of \$0.027466 is the lowest per-unit fuel cost in the last 14 months. As stated in the response to STAFF-DR-01-001, it is the closest actual per-unit fuel cost to the projected per-unit fuel costs for 2013 and 2014 of \$0.025727.
