# ORDER

On February 26, 2013, Kentucky Industrial Utility Customers, Inc. ("KIUC") filed a motion seeking to amend the existing procedural schedule. KIUC requests that the current deadlines for the following items be extended as follows:

- Supplemental requests extended from March 4, 2013 to March 8, 2013
   (by noon);
- Kentucky Power's responses to supplemental requests extended from March 15, 2013 to March 21, 2013;
- Intervenor testimony extended from March 25, 2013 to April 1, 2013; and

 Requests for Information to intervenors extended from April 8, 2013 to April 10, 2013.

Given the scope and complexity of the case, as well as the enormous amount of data and information to be produced, reviewed, and analyzed by the parties, KIUC contends that good cause exists for an extension of the current procedural schedule and that such an extension would not unduly delay the resolution of the instant proceeding. The motion further indicates that KIUC and the parties to this matter have all agreed on the proposed amendments to the procedural schedule.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that KIUC has established good cause to revise the current procedural schedule. The Commission further finds that a formal hearing should be scheduled.

## IT IS THEREFORE ORDERED that:

- 1. KIUC's motion to amend the procedural schedule is granted.
- 2. The procedural schedule set forth in the Appendix to this Order is substituted for and replaces the procedural schedule set forth in the Appendix to the Commission's Order of January 25, 2013.
- 3. All provisions of the Commission's January 25, 2013 Order that do not conflict with this Order shall remain in full force and effect.
  - 4. The official record of these proceedings shall be by video only.
- 5. Kentucky Power shall publish notice of this hearing in compliance with the provisions set out in 807 KAR 5:001, Section (9)(2).

6. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
