I would like to submit a further comment on the second rate increase requested by Big Rivers Corporation.

I suppose because of the bitterly cold weather we are experiencing at this time, we are well aware that the meter is ticking as we attempt to keep warm and survive without harm under these extreme weather conditions.

Most publicity indicates that a \$25 or \$30 per month increase could be given (depending on usage). This is to make up for a tremendous loss of income by Big Rivers Corporation when another customer leaves in January. I view this as a tax on customers of Big Rivers.
