I have been a Big Rivers' employee for 35+ years, based at the Coleman Station for that whole time. My understanding is that Big Rivers' plants were built to satisfy the electricity needs of the nearby smelters and residential customers on a non-profit basis. To my knowledge, we have always run our plants at or about full load, serving those needs.

I am also a part-time farmer. The only way that I have ever been able to make the money I need to farm is to sell a product, whether that be cattle, tobacco, or grain.

It seems to me that Big Rivers needs to sell power to the smelters, not shut down plants and raise rates on their remaining customers. If Big Rivers' CEO and Board of Directors cannot make a deal to accomplish this, then the PSC or Kentucky Legislators need to step-in and take charge.

At our last all-hands meeting, we were told this is a game of chicken, and that Mark Bailey, Big Rivers' CEO, is not going to blink. I do not see how this position is in the best interest of Big Rivers' customers. It also seems to fall well short of excellence, teamwork, integrity, and respect for the employee, all of which are listed as core values of Big Rivers Electric Corporation.
